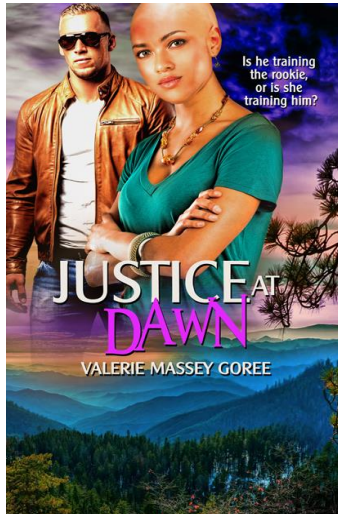

Question 7: KC does not want to be called a 'cancer survivor'. What were her reasons? If you know of a person who is now cancer-free, what might he or she say about KC's reaction?

Answer 7: Partial answer: KC stated her cancer would come back any time, so she did not consider herself a survivor.

Question 8: What part does faith play in dealing with illnesses that affect the whole family?

Question 9: If KC could have had a discussion with Travis, do you think she could have gotten him to open up about his personal struggles? Why do you think Travis acted the way he did?
