

## **About the Book**

TITLE: Protecting Annie Discussion:

Question 1: What does Annie refer to in most situations?

Answer 4: When Annie's spectacles are broken, Gertrude assists her in the schoolroom as well as helping with meals until Annie can see again.

Question 5: Josh eventually warms to the idea of a mail-order bride. How does he feel when she doesn't arrive on the stagecoach?

Answer 5: As much as he was resistant to the idea when Jules suggested it to him, he finds himself interested in having a wife and settling down. When his bride fails to show, he's disappointed.

Question 6: When faced with struggles in their past, how did both Annie and Josh respond?

Answer 6: They both responded by running away from the situation – choosing to ignore things and avoiding the situation when at all possible.

Question 7: What truths do Annie and Josh discover about the baggage from their past?

Answer 7: It's part of who they are – part of their story. They both need to learn to work through things from their past and instead choose to walk in who God created them to be.

Question 8: How does Josh react when faced with his greatest fear?

Answer 8: Because he's already started to address some of the hurts/pain in his past, he does a little better job of dealing with Annie's sickness although he still struggles with it.

Question 9: How did Josh learn to be who God created him to be?
