Answer 3: Discussion question; no right or wrong answer

Question 4: Muriel wonders if Natalie might have turned out better if she raised her differently. What do you think?

Answer 4: Nature vs. Nurture. Maybe Natalie would have rough edges taken off.

Question 5: Should Muriel have sued Kevin's parents?

Answer 5: It was to her advantage to become friends with them. Otherwise she wouldn't have met Clarence.

Question 6: Is Muriel's poverty a true obstacle in her relationship with Clarence? Or are her views too old-fashioned?

Answer 6: Clarence doesn't consider her objections valid.

Question 7: What is a Gideon's fleece? How is it different from tossing a coin?

Answer 7: See Judges 6: 36-40. Asking God for an answer is different than tossing a coin.

Question 8: Muriel says Chloe should have done things in a different order. What does she mean?

Answer 8: Marry before becoming intimately involved.

Question 9: Does Muriel's view of God change during this took?

Answer 9 Yes. She has a limited view of His powers at the beginning and doesn't want to bother Him with small things. At the end she realizes His thoughts are higher than hers.

Question 10: How would Muriel have responded to the carjacking if she were not a Christian?

Answer 10: More panic. Maybe more of a desire to hurt Kevin.
